	The Chairman intends to present his plan for documenting the history of the Commission and will request assistance from the members of Commission VI for several items. In addition, the Chairman requests a discussion on how we could work more efficiently during and between meetings and perhaps at additional meetings during the year.

11. Welding and Allied Processes Terminology Documents (VI-1259-2019) This document has been updated with the assistance of Carl-Gustaf Lindewald. 12. Report from Sub-commission VI-A – Jerome Dietsch (Chairman) 13. Commission VI Business Plan (VI-1260-2019) The Chairman requests approval of the business plan (via Resolution). 14. Report on ISO TC 44 SC 7 Activities (VI-1261-2019) – Jerome Dietsch (IIW Liaison) 15. Report on ISO TC 61 Activities (VI-1262-2019) – Mike Troughton (IIW Liaison) 16. Discussion Paper on Terms and Definitions in the ISO/TR 25901 Parts (VI-1234-2018 and VI-1263-2019) The Chairman requests that these two documents be discussed carefully and thoroughly in order to have a credible and operational plan for developing vocabulary documents in IIW for submittal to ISO. 17. ISO On-line Browsing Platform (OBP) Problems and Suggested Solutions (VI-1235-2018) This document has awakened the ISO Central Secretariat to numerous problems with the OBP. It has also led to some unintended consequences regarding the "Source" part of the documentation. Jerome Dietsch will discuss a particular problem with ISO/TR 25901-2 and the Chairman will discuss his interactions with the Manager of the OBP. 18. ISO/TR 25901 Part 1: General Terms (VI-1156-2015, VI-1250-2018, VI-1264-2019, and VI-1265-2019) - Carl-Gustaf Lindewald (Project Leader) Reference Documents: VI-1115-2014 and VI-1116-2014 There are now several new documents pertaining to the revision of this part of ISO/TR 25901, and the systematic review is scheduled for 2021. Mr. Lindewald has agreed to be Project Leader for this revision and will lead the discussion during the mornings of 8, 9, and 10 July. All members of Commission VI are cordially invited to attend and participate in this meeting. 19. ISO/TR 25901 Part 2: Health and Safety (VI-1226-2018) – Jerome Dietsch (Project Leader) Mr. Dietsch will provide an update on the status of this document. 20. ISO/TR 25901 Part 3: Metal Welding Processes (Revision of ISO 857-1), (VI-1210-2017) – Jerome Dietsch (Project Leader) Reference Documents: VI-1115-2014 and VI-1116-2014 There are no new documents pertaining to the revision of this part of ISO/TR 25901, and the systematic review is not scheduled until 2021. There is also insufficient time to discuss this item at the Annual Assembly this year. 21. ISO/TR 25901 Part 4: Arc Welding (VI-1118-2014, VI-1119-2014, VI-1135-2015, VI-1198-2016, VI-1221-2016, VI-1266-2019) – Jerome Dietsch (Project Leader) Reference Documents: VI-1115-2014 and VI-1116-2014 There are now six documents that relate to the revision of this part of ISO/TR 25901. The systematic review is not scheduled until 2022, but it may be time to decide who will put together a concise proposal that includes the six documents. There will be insufficient time to discuss details at this meeting, but the Chairman requests that a plan of action be approved. 22. Resistance Welding Terms and Definitions (VI-1201-2016 and VI-1251-2018) ISO TC 44 SC 6 has indicated that it may be interested in completing a part of ISO/TR 25901 on this topic. The Chairman requests that a resolution be agreed to send to WG-STAND asking WG-STAND to inquire whether ISO TC 44 SC 6 will accept this task or shall Commission VI develop the document.

23. Laser Welding Terms and Definitions (VI-1158-2015, VI-1159-2015, VI-1222-2017, VI-1224-2017, VI-1252-2018, VI-1267-2019, and VI-1268-2019) – Mathias Lundin (Project Leader)

The Chairman considers this to be the most important document for discussion at the Annual Assembly. VI-1267-2019 includes all the changes agreed up to the end of the intermediate meeting in January 2019. VI-1268-2019 includes two major changes to VI-1267-2019 for discussion. The first change involves the inclusion of new terms and definitions as a result of the approval of the revision of ISO III45-2018, which made extensive changes to the 2016 edition. The second change involves the inclusion of some terms and definitions from AWS C7.2M:2010.

The Chairman suggests that this document be discussed on Tuesday afternoon, 9 July 2019. Mr. Lundin will lead the discussion.

24. Thermal Cutting Terms and Definitions (VI-1161-2015 and VI-1269-2019) – Kin-ichi Matsuyama (Project Leader)

Due to the lack of sufficient time for many other important items on the agenda, the Chairman suggests that this document be deferred to the intermediate meeting in January 2020.

**25**. Plastics Welding Terms and Definitions (VI-939-2009, VI-1096-2014, VI-1178-2016, VI-1242-2018, VI-1253-2018, and VI-1270-2019) – Mike Troughton (Project Leader)

The Chairman considers this to be the second most important document for discussion at the Annual Assembly. VI-1270-2019 includes all of the changes agreed at the intermediate meeting in January 2019. At that meeting the discussion stopped at "horn analyzer" on page 33.

The Chairman suggests that this document be discussed on Wednesday afternoon, 10 July 2019 beginning on page 34 with the term "hot air seam welding." Dr. Troughton will lead the discussion.

If there are some remaining items from Monday afternoon, the discussion on plastics welding can continue after those items. The Chairman also suggests that agenda items 26 through 31 be discussed immediately following the afternoon break.

26. Friction Stir and Spot Welding Terms and Definitions (VI-1180-2016 and VI-1181-2016)

There are no parts of ISO/TR 25901 devoted to this topic and there are many more important items on our agenda. The Chairman suggests that this agenda item be deleted from our work program until such time as these terms and definitions are included in a part of ISO/TR 25901.

27. Electron Beam Welding Terms and Definitions (VI-1202-2016) – Ernest Levert (Project Leader)

Due to insufficient time and there being many more important items on our agenda, the Chairman suggests that this agenda item be deferred until the intermediate meeting in January 2020 where a preliminary discussion can be held to determine who will lead this project and when a draft for discussion will be ready.

**28**. Figures for Commission VI Vocabularies (VI-867-2007, VI-873-2008, VI-926-2009, and VI-953-2010) – Dietmar Rippegather (Project Leader).

Due to the ready availability of figures from other documents that are already published, perhaps the older documents cited in this agenda item can be deleted and the discussion of figures can be held under the specific technical subject matter. Before deletion, the Chairman requests a short discussion on this item.
